C5ISR Integration

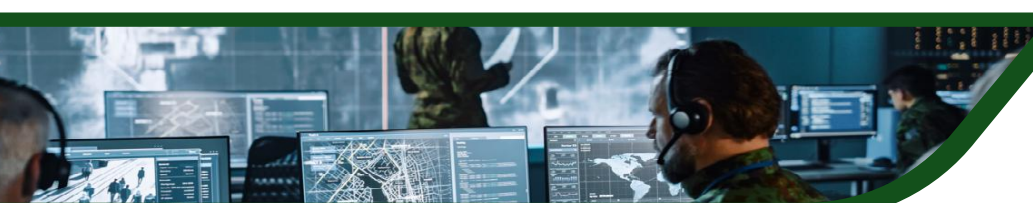

Supply Chain Risk Management
